THE FOLLOWING GUIDELINES SHALL APPLY AT ALL TIMES.

FAILURE TO ADHERE TO ANY CONDITIONS OF THE PERMIT MAY RESULT IN PERMIT REVOCATION:

1. NO DUMPSTERS SHALL BE HIGHER THAN 5 FEET TALL, AS MEASURED FROM THE PAVEMENT.
2. ALL DUMPSTERS/CONTAINERS SHALL HAVE REFLECTIVE MATERIAL TO ENSURE VISIBILITY TO ALL VEHICULAR TRAFFIC.
3. DUMPSTERS SHALL BE COVERED AT ALL TIMES TO PREVENT DEBRIS LEAVING THE CONTAINER.
4. NO DUMPSTER SHALL BE FILLED HIGHER THAN THE PERIMETER EDGES OF THE CONTAINER.
5. THE PERMITTEE SHALL BE RESPONSIBLE FOR PROTECTING THE ROADWAY WITH PLYWOOD OR OTHER MEASURES AND WILL BE RESPONSIBLE FOR DAMAGE TO THE ROAD.
6. DUMPSTERS/CONTAINERS MUST BE KEPT WITHIN 12 INCHES OF THE CURBLINE.
7. 10 FEET CLEAR TRAVEL LANE(S) MUST BE MAINTAINED IN ALL INSTANCES (10' ONE WAY STREET / 20' TWO-WAY STREET).
8. ALL CONTAINERS/DUMPSTERS MUST HAVE OWNER INFORMATION PERMANENTLY AFFIXED.
9. CONTAINERS/DUMPSTERS MAY NOT BE WITHIN 20 FEET OF A FIRE HYDRANT NOR 25 FEET OF AN INTERSECTION, DRIVEWAY, OR ALLEY.
10. PERMITS ARE VALID FOR 90 DAYS AND ARE NON-RENEWABLE. A NEW PERMIT IS REQUIRED.
11. TRAILER PARKING IS PROHIBITED PER CITY ORDINANCE, AND MAY NOT BE PERMITTED FOR USE WITH THIS DOCUMENT.
12. PERMITTEE IS RESPONSIBLE FOR SNOW REMOVAL AROUND THE DUMPSTER OR CONTAINER.
13. CONTAINERS ON SNOW EMERGENCY ROUTES MAY BE ORDERED TO BE REMOVED AT CITY'S DISCRETION.
14. NO LIABILITY SHALL ACCRUE TO THE CITY BY VIRTUE OF THE ISSUANCE OF THIS PERMIT. PERMIT HOLDER IS SOLELY RESPONSIBLE FOR THE SAFETY OF HIMSELF AND THE PUBLIC RELATIVE TO ACTIVITIES RELATED TO THIS PERMIT. PERMIT HOLDER INDEMNIFIES THE CITY AGAINST ANY AND ALL CLAIMS RESULTING FROM THE PLACEMENT OF A DUMPSTER, CONTAINER, OR ANY OTHER MATERIALS RESULTING FROM THIS PERMIT.
15. NO PARKING SIGNAGE MUST BE OBTAINED FROM A SERGEANT AT LCPD AND METERED PARKING AREAS MUST BE RESERVED THROUGH LANCASTER PARKING AUTHORITY.
