- 2. If information is not received by the City in a timely manner, you will need to estimate the water/sewer & trash bills, real estate taxes, and any other information and hold that estimated amount due to the City in escrow.
- 3. No settlement information will be provided without all completed information, including all the new owner information.
- 4. If located in Lancaster City a completed smoke detector certification will be required before information is provided.
- 5. Please allow 2 FULL business days for finals to be returned to you, once all of the above steps have been completed.
- 6. Please complete a water application with new owner information and submit the application with final payments.
